THE SCHEDULE

Tuesday 10th November 2015

- 8.15pm Guests take their seats in the debating chamber.
- 8.30pm Welcome and thanks from Jayne Woodley, CEO of Oxfordshire Community Foundation, and the President of the Oxford Union, Charles Vaughan.
- 8.40pm Debate starts with the first speaker in favour of the motion, followed by the first in opposition. These two speakers are said to 'move' the case for each side of the debate. All speakers have eight minutes to make their contribution. After these two speakers, there is a further speech from each side of the debate.
- There will then be a debate from the floor (led by the President) – an opportunity for audience members to join in the debate with questions and personal viewpoints, as well as rebuttals from the speakers. Please be vocal!
- Once the floor debate has finished, the final speaker on each side will present their side's closing arguments.
- 10.15pm Audience votes for or against the motion – voting will be recorded by a show of coloured cards, with green signifying support for the motion, and red signifying opposition.
- 10.30pm Closing remarks from Charles Vaughan and Jayne Woodley; debate ends.

Notes for the audience

The audience may only interrupt speeches using a Point of Information or a Point of Order. Should you wish to raise a point, please stand up, raise your hand and state which type of interruption you are making.

- **Point of Information:** This type of interruption should be used to clarify or question a point of information, such as a statistic or information presented as fact by the speaker, and not to express an opinion. The speaker can choose to accept or refuse a point of information.
- **Point of Order:** Such an interruption must only be used to draw the President's attention to an abuse of the Forms of the House, such as a slanderous remark that you wish to be withdrawn. Speakers must give way to a point of order.
