Whatever the reason, a donor advised fund is often the most effective way of carrying out great charitable intentions. They can be created to campaign for a cause local to you, as a way of demonstrating impactful CSR, or simply because you can and want to make a difference in Oxfordshire.

You can be as involved as you want to be in how the fund is used or you can leave it to us to decide. Our experience of managing funds, together with our research insights have given us an in-depth understanding of the most urgent social problems, the priority issues and their locations within Oxfordshire.

By giving through OCF in any way, your charitable gift is worth significantly more than it would have been via a conventional donation.
